These lytic myoviruses were enriched on *Arthrobacter* and isolated in Lithuania (arthrobacter phage vB_ArtM-ArV1) and Laurel Springs (NJ, USA, arthrobacter phage PrincessTrina). They possess circularly permuted genomes. NCBI BLASTN, CoreGenes (Table 1) [2], progressiveMauve alignment (Fig. 2) [1] and phylogenetic analyses (Fig. 3) [3] all indicate that the proposed genus, *ArvIvirus*, is cohesive and distinct from other genera. On average, the genomes of members of this genus are 70.73 kb in length (61.6 mol% G+C), and encode 105 proteins and 0 tRNAs.

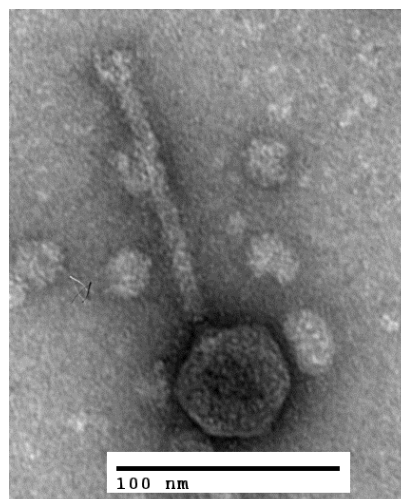

Fig. 3. progressiveMauve alignment [1] of the annotated genomes of members of the *Arvivirus* genus— from top to bottom: Arthrobacter phages PrincessTrina and vB_ArtM-ArV1. Colored blocks indicate the regions of 1 to 1 best alignment with rearrangement breakpoints in a different random color. The degree of sequence similarity between regions is given by a similarity plot within the colored blocks with the height of the plot proportional to the average nucleotide identity (Aaron Darling, personal communication).

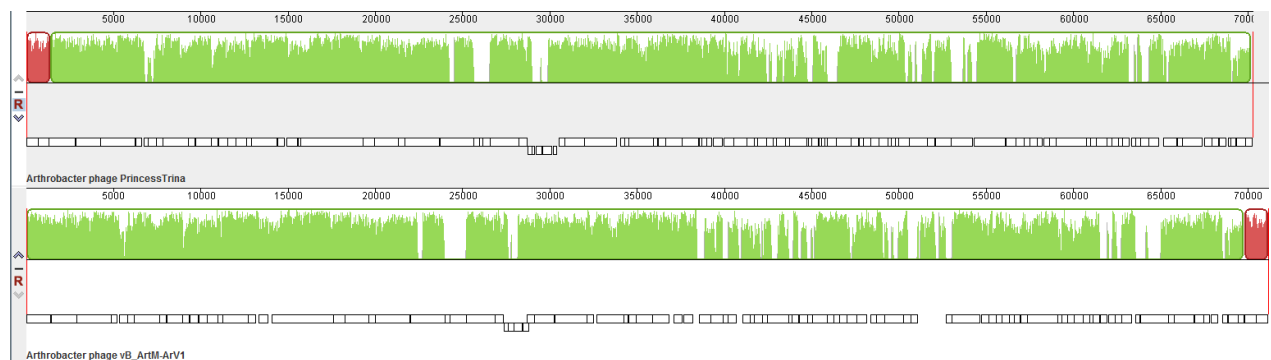


Fig. 4. Phylogenetic analysis of (A) large subunit terminase proteins, (B) major capsid proteins and (C) tail sheath proteins of Arthrobacter phage vB_ArtM-ArV1-like viruses and homologous proteins from a variety of other phages constructed using “one click” at phylogeny.fr [3]. "The "One Click mode" targets users that do not wish to deal with program and parameter selection. By default, the pipeline is already set up to run and connect programs recognized for their accuracy and speed (MUSCLE for multiple alignment and PhyML for phylogeny) to reconstruct a robust phylogenetic tree from a set of sequences." It also includes the use of Gblocks to eliminate poorly aligned positions and divergent regions. "The usual bootstrapping procedure is replaced by a new confidence index that is much faster to compute. See: Anisimova M., Gascuel O. Approximate likelihood ratio test for branches: A fast, accurate and powerful alternative (Syst Biol. 2006;55(4):539-52.) for details."

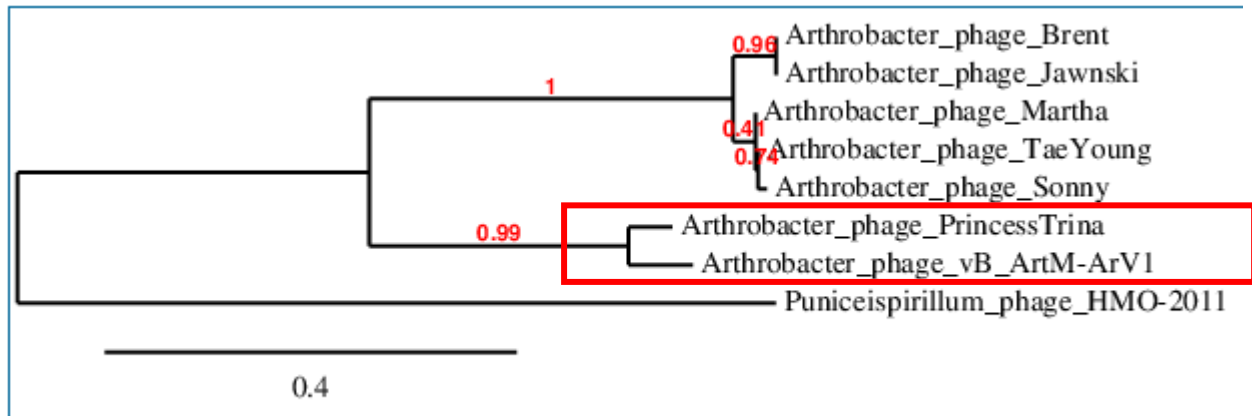


Figure 1: Phylogenetic tree.

B. Major capsid proteins

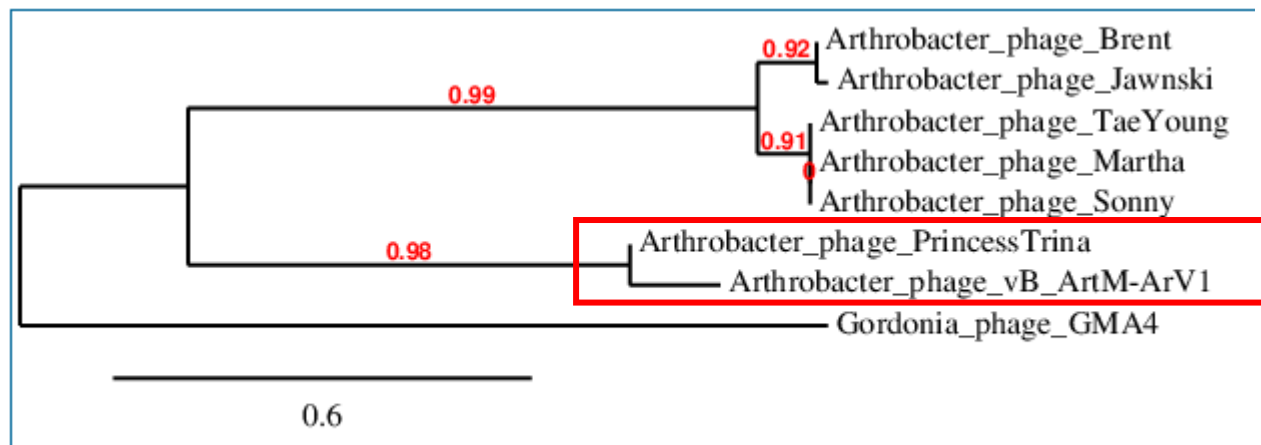


Figure 1: Phylogenetic tree.

C. Tail sheath proteins

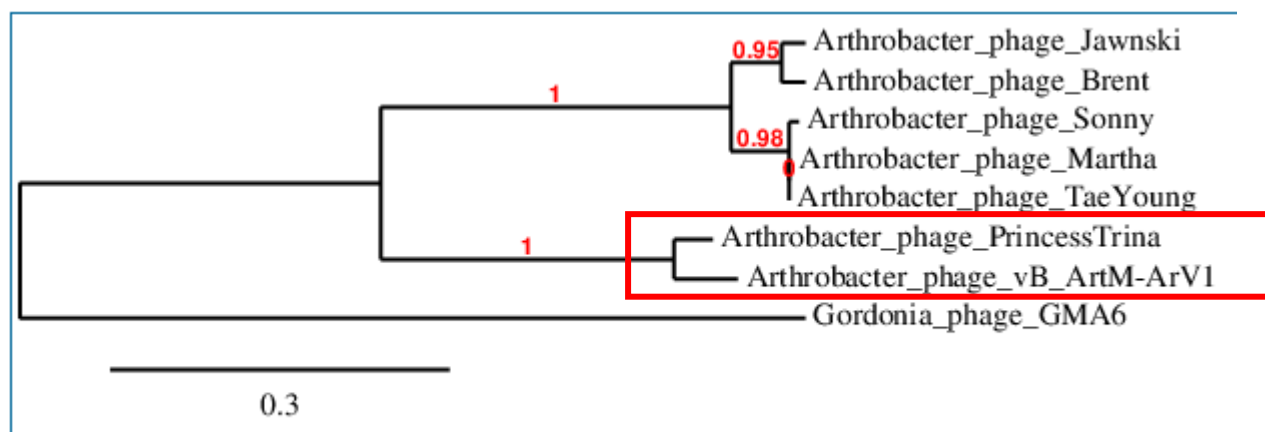


Figure 1: Phylogenetic tree.
